To be eligible for the TEG Grant, a student must:

- Enroll in courses applicable to your academic major
- Be a Texas resident
- Complete the FAFSA before the priority deadline, April 15th
- Adhere to Satisfactory Academic Progress requirements
- Obtain a minimum cumulative grade point average of 2.5 each Fall and Spring term
- Minimum of 9 credit hours must be completed each Fall and Spring term
- **Undergraduates**- are required to complete 24 credit hours each academic year (Fall, Spring and Summer)
- **Graduates**- are required to complete 18 credit hours each academic year (Fall, Spring and Summer)
