HISTORICAL NOTE

Frank H. Bredeweg, CSB arrived in 1965 from the University of Toronto to serve the University of St. Thomas for four years as treasurer and controller. He was instrumental in coordinating new federal and state programs for St. Thomas as well as serving on the Southwest Region Government Programs Board and the Federal A.I.D. Program.

From 1975 to 1981, Fr. Bredeweg continued to actively consult and develop programs for dioceses, religious communities and Catholic academic institutions throughout the U.S. and Canada, especially those of the Congregation of St. Basil. He had an extensive background in both education administration and finance management.

Because the University was faced with financial difficulties, Fr. Bredeweg came as a troubleshooter and was asked to stay as President in 1985. The university got into financial trouble because it simply expanded into too many programs – taking on more sports and teaching activities than it could afford. Fr. Bredeweg led a cost-cutting campaign that eliminated the school’s nursing program, varsity athletic programs and department of continuing education. Times were very hard and many other sharp cuts had to be made in order to help solve the university’s financial problems.

Fr. Bredeweg put into action immediate plans for setting the university on a sound financial basis by outlining plans for the newly formed “Friends of the University”, a group of benefactors entrusted with raising \$1 million to offset our deficit. After three years, he announced his resignation because he had accomplished his mission of getting the university out from under its \$1 million deficit.

BIOGRAPHICAL NOTE

Frank H. Bredeweg, CSB was born January 13, 1928 in Detroit, Michigan. He had a career as a certified public accountant before discerning his priestly vocation. It was in 1959 when he chose to enter the priesthood joining the Congregation of St. Basil. He served as a teacher at Aquinas High School in Rochester, N.Y. from 1960 to 1961 and was ordained in 1964.

During the 1970s and early 1980s, he consulted with Catholic universities throughout the United States and Canada as a financial planner and manager. He served as Director of the Basilian Center for Financial Management and as the Director of Special Projects for the National Catholic Education Association.

He was an accomplished pianist. He could play for hours with no sheet music, and never repeat a song. Many of his confreres have memories of Fr. Bredeweg at the piano and leading sing-a-longs during the 1996 Basilian Synod or at General Chapters. According to his nieces and nephews, similar events were often part of the family get-togethers.

He received his BS in economics and accounting from the University of Detroit in 1952; BA in theology from the University of Toronto in 1965 and an MA in theology from the University of Notre Dame in 1969.

Fr. Bredeweg died peacefully on Good Friday, April 10, 2009 at the age of 81. He was a good man who had done great service to the Congregation and the Church.
